



Warranty

COMPANY, warrants that it will repair or replace, at its discretion, Invisible Fence® Brand products which prove defective by reason of improper workmanship and/or material for the period of time specified below.

All warranties in this agreement are granted for the sole use of original client and are not transferable. Any modifications or alterations to the system may result in the denial of a warranty claim. Client's sole remedy for any breach of the limited warranties described below shall be to have the defective equipment repaired or replaced with the same model or an upgraded version, at COMPANY's discretion.

LIFETIME LIMITED WARRANTY - The lifetime warranty for the following equipment shall be in effect for as long as the original purchaser owns such equipment.

Includes:

- ICT Series, Boundary Plus® and Invisible Gate® Transmitters installed with an approved lightning protection device. Warranty also includes electrical surge damage. R21/22 Platinum and Titanium, R51 Platinum, MicroLite®, MaxDog™ and Boundary Plus® Computer Collar® Units.
- Invisible Mask® II
- Nylon collar. Dog chews are covered for a period of one (1) year from the date of original purchase at retail. Proof of purchase may be required.

Does not include (as summarized throughout this document):

- Gross neglect or abuse.
- Broken or spun posts
- Any modifications or alterations to the system; including damage caused by third-party accessories, batteries, or power supplies

2-YEAR LIMITED WARRANTY - Invisible Fence® Brand GPS Containment, Rechargeable Batteries, Battery Chargers, Shields® and Doorman™ products are warranted for a period of two (2) years from the date of original purchase at retail. Exception - Broken or spun posts are not covered under warranty.

BATTERIES - COMPANY does not warrant the primary cell batteries used to power Invisible Fence® Brand equipment. COMPANY will not cover damage caused by third-party accessories, batteries, or power supplies. Invisible Fence® Brand accessories, batteries and power supplies are not required to be used in connection with your Invisible Fence® Brand system, but we recommend that you use only Invisible Fence® Brand accessories, batteries and power supplies.
